

**OFFICIAL RULES**  
**THANKSUSA SUMMER SNAP-SHOT**

NOTE THAT DONATIONS WILL NOT INCREASE YOUR CHANCES OF WINNING.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Office Rules. All federal, state and local laws and regulations apply. The act of making of a donation to ThanksUSA does not improve the chances of winning.

**CONTEST PERIOD AND ENTRY DEADLINE**

The ThanksUSA Summer Snap-Shot (the "Summer Snap-Shot") will be held from June 6, 2010, at 11:59 Eastern Daylight Time (EDT) through August 28, 2010, at 11:59 p.m. (the "Contest Period"). The Summer Snap-Shot will consist of twelve (12) questions (the "Questions") with twelve (12) corresponding prizes, as well as one grand prize. Each Sunday, ThanksUSA will post a new Summer Snap-Shot Question. The deadline dates (the "Entry Deadline Date") for each Question is as follows:

Entries must be submitted online (or postmarked if submitted via mail) by 11:59 p.m. EDT on the Entry Deadline Date indicated in the Prize Schedule shown above, in order to be eligible to win a prize for any of the Questions including the Grand Prize.

**ELIGIBILITY**

The contest is open to legal U.S. citizens. Parental permission is required for entrants 14 years of age and younger as of the date of Registration or Postmark Entry Date. Registration can be made on the ThanksUSA Web Site <http://www.ThanksUSA.org> (the "Web Site"). Any Participant (including but not limited to employees, consultants, independent

contractors and interns) who, within the past six months, has performed services (with or without compensation) for ThanksUSA or any affiliated organization, or any members of their immediate families living in the same household or not of such Participant, is not eligible to win.

The Summer Snap-Shot is void in Puerto Rico and where prohibited by law.

## **HOW TO ENTER**

### Questions

The Questions are available on the ThanksUSA Web Site.

### Entry Submission

Answers to each Question of the Summer Snap-Shot may be submitted in the following two ways: (1) Online: Complete the online entry form in its entirety for one or more of the Question and click on the "Submit" button; or (2) By mail: Legibly hand-print on a 3"x 5" card the words "ThanksUSA Summer Snap-Shot" along with your name, address, e-mail address (if available), statement affirming status as U.S. citizen, date of birth, signature of parent or guardian if entrant is under 14 years of age, telephone number and answers to one or more of the Questions of the Summer Snap-Shot, and mail the entry to:

All entrants who successfully answer all twelve (12) Questions of the Summer Snap-Shot and submit the correct answer will automatically become eligible to win the Grand Prize.

Only one entry per person. All entries become the exclusive property of ThanksUSA and will not be acknowledged or returned. Any use of robotic, automatic, programmed or any other non-manual entry methods will be void. Entry materials or data that have been tampered with or altered are void. Further, ThanksUSA will prosecute, to the full extent of the law, any applicants who use illegal entry methods.

### Lost Entries

ThanksUSA is not responsible for lost or incomplete entries due to interrupted or unavailable networks or telecommunications transmissions; problematic phones, computer hardware or software, servers; miscommunications; technical failures; garbled or jumbled transmissions; or other errors of any kind, whether human, mechanical or electronic (including without limitation the incorrect or inaccurate capture of entry information online), or for lost, late, incomplete, damaged, destroyed, delayed, stolen, misdirected or illegible entries submitted by mail.

## **ODDS**

Odds of winning depend on the number of eligible entries received. There will be one winner per Question and one Grand-Prize winner.

## **WINNER SELECTION**

### Entry into Random Drawing

Entries will be considered eligible only if (1) they are received by the relevant Entry Deadline for that particular Question, (2) all eligibility requirements set forth in these Official Rules are met; and (3) the correct answer is submitted for the Question. All decisions made by ThanksUSA in connection with answers to the Questions are final and binding. A Participant may not win the prize for more than one Question.

### Winner Selection by Random Drawing

One (1) winner for each of the twelve (12) Questions will be determined by random selection among eligible entries. One (1) winner will also be determined by random selection for the Grand Prize from among all those eligible entrants who successfully solve all twelve (12) Questions of the Summer Snap-Shot. Winners will be announced and notified after each drawing.

### Claiming Prizes

The winners will be posted on the Web Site and all winners will be notified by phone, e-mail or U.S. mail on or before December 31, 2010. Winners will have 15 days from the date of notification (as determined by the date of e-mail or date of postmark, as applicable) to accept their prize either by e-mail or by U.S. mail to the address specified in the notification. Within five (5) days of acceptance, winners will be required to sign a declaration of eligibility and to furnish certain documentation to support such declaration. Winners may also be required, where lawful, to sign a publicity consent agreement authorizing the use of their name, photographs, voices and likenesses for publicity purposes.

ThanksUSA is not responsible for and shall not be liable for any late, lost, or misdirected notifications or acceptances (e.g., in the case of any change of address), or for winner's unsuccessful efforts to claim any prize. If a selected winner cannot be contacted, is ineligible, fails to claim a prize, or fails to timely return the completed and executed declaration and releases as required, the prize may be forfeited and an alternate winner may be selected in accordance with these Official Rules. In the event of the dispute regarding who submitted an online entry, the entry will be deemed submitted by the authorized account holder of the e-mail account. The right to claim a prize may not be sold, traded or transferred, and prizes may not be substituted or redeemed for cash value.

### Change of Contact Information Policy

It is the sole responsibility of the Participant to update their profile at [www.ThanksUSA.org](http://www.ThanksUSA.org) if the Participant changes his or her e-mail address, mailing address or phone number during the Contest Period.

## **PRIZES**

Prizes will be awarded in the following manner: Prize #1 to the winner of the drawing for Question #1; Prize #2 to the winner of the drawing for Question #2; Prize #3 to the winner of the drawing for Question #3; and so forth for each of the twelve (12) drawings corresponding to each of the Questions of the Summer Snap-Shot.

The Grand Prize winner will be determined by random selection from among all the eligible Participants who successfully answered all twelve (12) Questions of the Summer Snap-Shot.

A complete list and description of the prizes, along with any relevant restrictions, can be found on the ThanksUSA Web Site during the Contest Period.

All applicable federal, state and local taxes are the sole responsibility of the winner. No alternative prize, cash, or other substitution is permitted except by ThanksUSA in the event of prize unavailability.

## **INDEMNIFICATION**

By participating in and entering the Summer Snap-Shot, each Participant agrees, and by accompanying a winner on any travel involved with a prize, the winner's guest (or guests) agrees (agree) to hold ThanksUSA, its affiliated entities, agents and representatives, subsidiaries, advertising, promotion, and fulfillment agencies, sponsors and legal advisors harmless from any claim, damage, loss or injury which may arise, directly or indirectly, as a result of any and all elements of such Participant's participation in the Summer Snap-Shot or the acceptance or use of any prize(s) awarded therein.

## **GENERAL TERMS AND CONDITIONS**

### Cancellation, Suspension or Modification of Summer Snap-Shot

ThanksUSA reserves the right, in its sole discretion, to cancel, suspend and/or modify the Official Rules at any time.

### Disqualification

ThanksUSA reserves the right in its sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the contest or to be acting in violation of or contrary to the Official Rules.

### Resolution of Disputes

Any and all disputes and claims relating to the Summer Snap-Shot shall be resolved by binding arbitration under the laws of the District of Columbia. District of Columbia law shall apply to the resolution, award, enforcement and collection relating to any dispute or claim. Each party shall pay one-half of the costs of the arbitration. The dispute and claims and arbitration proceedings shall at

all times be kept confidential except to the extent necessary to enforce or collect the arbitration award.

### Privacy

ThanksUSA will not rent, swap or sell entrant's information to any third party.
